The quiz starts on 11 December 2017, upon activation of the quiz form on the website: www.plru.eu, and ends on 18 December 2017, at 5 p.m. The Organiser reserves the right to: make changes to the Quiz Rules, interrupt, change or cancel the competition without submission of reasons. Information on any changes will be published only on the website www.plru.eu exclusively.
6. The personal data of participants will be deleted on 21 December 2017 when the contest is officially closed.
7. To take part in the contest, please visit the website of the Poland-Russia Programme, under the link: www.plru.eu, register at the indicated place, declare consent for processing the personal data, click on the link, which is available below the information about the contest and answer 14 questions regarding the Poland-Russia Cross-border Cooperation Programme 2014-2020, both countries – Poland and Russia and their Christmas and New Year traditions. For each question, only one out of three answers is correct.

9. The participants who will get the highest scores will be given prizes.
10. The 5 people who will get the highest scores will receive the top prizes. The Organiser reserves the right to carry out a draw if the number of persons entitled to receive the main prizes exceeds 5. The draw of the winners of the quiz will be conducted by a selection board.
11. The selection board consists of members appointed by the Organiser: The Joint Technical Secretariat of the Poland-Russia Cross-border Cooperation Programme 2014-2020.

17. Participants have no rights to claim the cash value of the prizes.
18. No participants who are not entitled to the main or special prizes can claim a prize.
